Quite simply, it's the first indication that we have as to what kind of a talent you are and if you are conscientious with attention to detail, so PLEASE make sure you follow that instruction when it's given!

You had a lot of energy and life to your reads, though I would have liked to have heard a little bit more of a variety between your two takes, as they both were pretty similar. That said, I enjoyed how you delivered "We really don't want to see this" in take 2. For future reads, try having more of a POV of the hands being at the paint n sip party (where they don't want to be) versus in the garage (where they do want to be).	No	Good	Good

Your pacing and delivery were really good, and you had that politeness and loveability that the specs were asking for coming through in your voice. I would have liked to have heard a bit more of a variance between takes, as both takes sounded pretty similar. Likewise, while you came across as friendly, it would have been good to hear a bit more of that Bob Ross quality in one of your reads. Maybe a bit more soft-spoken, humble, polite, and kind of amusing to yourself. Likewise, I think you could have made the second part of the script sound a bit more 'off the cuff' in your response. Have more fun with it! You had great range and variance between your takes, as I definitely felt the newscaster vibe in your first take, and you nailed the casual, conversational delivery in take 2. This is an interesting script because it's not until halfway through the spot that we as the listener figure out what the script is even about, and it's still a couple of lines after that that the product name is mentioned. So in cases like this, it would be helpful to maybe put a little extra love or emphasis on the word "mint" the first time you say it so it doesn't get lost in the text. Of course you don't want to overemphasize it, but just enough so we're clear that we're talking about mints and bad breath would be good.	No	Great	Great

You had a clear POV, good pacing, and connection to the words you were saying. However, all of that might have been entirely disregarded by a CD, agent, or client, who didn't bother to listen to a read that was mislabeled, so please be mindful of the casting instructions when submitting, as they really do matter. I really enjoyed your entire approach to the character, and you showed range in your takes by having a different POV in each of them. I'd say you could even take each of those characters a bit further. Get a little bit more dry with your take 1 approach, and a little bit sassier with take 2. Also, I would have liked to have heard a bit more variance between your takes, as your character was fairly consistent throughout so I would like to know what else you could have brought to her. However, I felt that perhaps you were concentrating so much on ensuring you hit the specs, that your performance took a back seat. I would have loved to have heard more of a POV and intention within your reads, as I wasn't sure who you were and who you were talking to, and why you would be talking to them in this smooth-talking or ASMR whispery way. This was certainly a tricky ask (because most people don't naturally speak in either of those ways!) but at least having an opinion about the words you say will have a great impact and influence on your delivery as you say them. Also, please ensure you fully follow the directions, as you submitted a .wav file rather than an .mp3.	No	Good	Needs Improvement
CurtFord-Breath Savers Curtis Ford	I loved your reads, Curt! You had an excellent grasp of both of the characters you presented, and you showed a great range between the two of them. I particularly appreciate your second take, as you even added in a little 'ugh' after "bad breath", which sounded genuine and authentic and made me smile. I will say that I would have liked to have heard a slight bit more of a POV in take 1, as your newscaster was very classic and straightforward (which was appropriate), but so much so that I wasn't quite sure who his audience was and how he felt about that audience. However, you did not fully follow the directions, as you read both the Hands and the Announcer roles, and the script and specs specifically mentioned this was for the role of Hands only. While your reads were truly quite good (you grasped the character, had great personality and energy, had an opinion about the paint n sip party vs your garage), CDs might stop listening when they hear you begin to read part of the copy that wasn't requested. Regarding your read itself, I would suggest picking up your pace quite a bit. It says it's a :30 (granted, there's no way all of that text was ever going to be read in 30 seconds!), but your reads were closer to a full minute including the AVO, so it definitely needed to be read quicker. You were very friendly and informative in your delivery, but I would have liked to have heard more of a distinction between reads, as your takes both sounded rather similar. Likewise, I didn't really get much of a 'weatherman' vibe from you, particularly in take 1, as I was almost wanting to hear you read each of those fragments as if they were entirely different elements, much like weather people gesticulate to show how the weather is different in different parts of a region. Perhaps demonstrate this by having a varying opinion on the ingredients as you say them, like maybe you are particularly excited about the roasted hazelnuts, so give that line a little extra love. You brought such life and energy to this spot, and gave such a clear distinction between the characters you created for each take, showing fantastic range. But your take 2 took me by total surprise, as your delivery was almost as if you were the 'devil on the shoulder' of the guy eating the wings, encouraging him in the most devious way. This was supposed to be a :30 and your reads went considerably over, so if I had a note it would be to try to condense it a little bit more (at least for one of the takes to show you were aware of its intended length), but since the timing wasn't explicitly stated it wasn't a big deal. I realize a pronunciation was not given in the specs, but when you have a product/brand you're unfamiliar with, it's good to Google it and find a video so you can ensure you're pronouncing it correctly! You did go a little in and out of your accent though, so I might have preferred to keep the 'tough guy' tone and drop the accent for that particular take. I did appreciate that you made take 2 more of your own. I would have liked to have heard a little bit more of your POV regarding what you're saying. The specs tell us you're talking to your son, but you can decide on his age, why you're talking to him about this, what it is that's happened to make you say these words, etc. Making a solid choice as to what your connection to this script is for each take will really elevate your reads to the next level. I hadn't heard it delivered that way before, so I really enjoyed that. My only real note is to maybe put a slight bit more emphasis on the word "mint" the first time you say it, as that is the first time the listener hears what the spot is actually about, so you don't want that word to get lost in the rest of the read. You differentiated between the two character versions beautifully, as your newscaster was very 'classic' announcer sounding, which was just what the specs were calling for. A nitpicky note though, is that in both takes you left out the word "bad" in "proven to neutralize bad breath", so be mindful of that and make sure when you're listening back that you've said all the words in the script correctly. That said, I would have liked to have heard a bit more variance in your character between takes, and also please be mindful about changing words in the script or ad libbing additional words. Take 1, while sounding a bit more in the Bob Ross world, was at a much slower pace than I think it needed, as it came in at around :45 whereas this was for a :30 spot (though I do realize that the timing was not listed on the script). Take 2 still had all of those elements requested in the specs, but felt at a more comfortable speed, though even that one came in at :37, so just be mindful of your timing for your reads. However, aside from the accent you added for take 2, the reads themselves were pretty similar, so I would encourage you to change them up a bit regarding your intention. I didn't really ever feel like you were speaking to your son, so making a strong choice on who you're addressing will really help. How old is your son? Why are you talking to him about this? Where are you having this conversation? What has just occurred to make you say these words? Answering those questions will give you the specificity needed to really elevate your reads, and you can vary your takes up by changing those answers while still keeping the accent (which was good!) I will note, however, that I didn't really hear a very clear distinction between characters on take 1 vs take 2. The specs had asked for take 1 to be a 'classic newscaster' a la Walter Cronkite, and I didn't really hear that in your read, as it sounded rather similar to take 2. That said, I did enjoy your delivery of the last line in both takes, as it had a clear POV and intention. I do want you to be aware though, that the last 9 or so seconds of your submission was the sound of you walking out of the booth, so please be mindful to listen back to your reads before submitting and ensure your edits are completely done. I would have loved to have heard more range in your takes, as they both sounded quite similar, and they also seemed to be a bit unclear as to your POV and intention. I wasn't sure who you were addressing and why, and that lack of specificity made your words sound a bit less authentic and genuine in your delivery. Knoppers Jacob Tarconish	Jacob, your reads were super fun to listen to and you definitely grasped the weatherman concept! However, I do think you took it a bit too far, particularly because you took those liberties in both of your reads. I think having pieces of each combined in just 1 take would be okay, but obviously this script is just supposed to be in the <i>style</i> of a weatherman, not actually a weatherman out in the elements getting blown away by a storm. That said, I applaud you for making a strong choice! Take 1 was more along the lines of what I was listening for, as you had the appropriate cheeriness and a clear POV and opinion about the words you were saying. But be careful about "eating" in your read, as you don't want to make it difficult to understand your words, so perhaps eating between phrases rather than inside of them would get that point across while still making yourself comprehensible. I loved take 1, as you had a clear POV and intention, and you seductively expressed your feelings about this burger in a flirtatious way. Take 2 encapsulated the ASMR whisper style very well, though I may have liked to have heard a bit more of a POV on that one. I realize that's a challenging task because people don't tend to speak in that whispery way, but perhaps sacrificing a small bit of whisper so you can clearly express your feelings about what you're saying would still work. Just be mindful to get the words perfectly correct, as in both takes you said "And <i>the</i> toasty egg bun" rather than "And a toasty egg bun". Small difference, but noticeable. Also, while the length of the script was not explicitly stated, perhaps one of your takes could have been read a little bit quicker, as both of your reads came in around 1 minute.	Yes	Great	Great

You differentiated between the two requested styles of read very nicely, and your second take was quite strong in your casual, conversational delivery. Your first take felt a bit cold and stoic, which I realize can be a way that newscasters from the Walter Cronkite era can come across, but I would be careful about going too far in that direction because it can end up sounding like you just don't like what you're talking about. You had the spirit of Nick Offerman in take 1, while still bringing yourself to the read, and you distinguished between the characters you created very nicely in each take. Your pacing was quick, but you landed both takes within the 30 seconds intended, so I applaud that effort since this script definitely felt a bit wordy for :30. My only note is the delivery for the very first part of take 1, as those first two sentences were so fast that the humor in them was almost a little lost, so for future reads I would suggest pacing out the beginning just a bit more and then maybe quickening the pace for the second paragraph to make up for it. That said, I would have liked to have heard more of a variance in your characters, as both takes sounded fairly similar. Perhaps creating a different reason to be speaking to your son, and maybe having your son be a different age in each take, in addition to changing your environment, would help distinguish between the reads a bit more. Also, having a clear point of view with this text would have helped inform your read, as it was missing a human connection from you as the narrator to the words you were actually saying. Lastly, there was a lot of noise in your audio, so if you don't have a booth or home studio, please make sure you record from a good quality microphone in a sound dampened space, because you don't want an otherwise good read to be dismissed due to poor audio. I heard a noticeable distinction between the characters you created in each take, and felt that they both had very clear and different points of view. I appreciate that you took your time with your read, but I do feel that you drew them out a bit too much, particularly take 1, which came in at over a minute. If you were to shorten the pauses you had in there, take 1 otherwise was great. However, your audio quality was not so great, as I could hear a lot of room noise (and outside sounds), as well as a lot of mouth noise, so make sure you're recording in as sound dampened of a space as possible. Because of this, I was also able to hear your edits since the sound cut in and out, and that is something you definitely want to avoid, so please be mindful of it in the future.	Yes	Great	Good

However, I feel like your reads were lacking that human connection to the text, as I felt you could have had a different delivery for each of those sections of the script in which the video was changing. For instance, the way you'd say the line as the image of a mom with a sick child comes across the screen, should be different from when a mom is holding a healthy newborn. Also, I'm not sure if your gain was turned up too high, but your audio came in really loudly. That's better than it being too low, but still I needed to turn the volume down so if you can be mindful of that for future reads, that's probably going to be helpful.	Yes	Good	Good

That said, you also could have picked up your pace a bit, particularly in take 2. You combined the essence of both voice styles into your reads, which was an interesting choice, but I wonder if it would be better to keep them as two totally separate styles. Take 1 felt more like the smooth-talking one, but still had a lot of the whisper style that is typical of ASMR, whereas Take 2 felt more ASMR-y, but still sounded similar to the previous take. I also noticed that you have a bit of uptalk at the end of some of your phrases, so they almost sound like a question ("fresh veggies", "dressed to the nines", and "tangy Smash Sauce" were particular ones of note in take 1). You also missed the last line in take 1, so make sure you listen back to your read after editing to ensure you've said everything in the script before you submit it!	Yes	Good	Good

You had a lot of personality in both takes, as well as a clear POV throughout. My only critical note is that your pacing could have increased a bit.
